DOG PARK RULES & REGULATIONS

OPENING HOURS: 8.00 AM – 8.00 PM
CLOSED ON MONDAYS FOR MAINTENANCE

1. All dog owners that are registered with Bandar Eco-Setia Sdn Bhd Management are only allowed to enter the park. For details and registration, please contact Canopy Club Front Desk or call 03-3344 3988 or 03-3343 2552.
2. Solo or group entries are only allowed for each session which last for 30 minutes. A group entry means “consenting parties wherein all parties are fully aware that either party’s dog are able to get along with the other dog(s)”. In any instance where there is a group entry, the person whose access card which is used to tag to enter the dog park shall be solely responsible for any incidents, accidents and mishaps that may occur during the session.
3. Each dog owner is only allowed to bring in a maximum of three (3) dogs per session.
4. All entries are on a first come first serve basis.
5. A maximum of ten (10) dogs will be allowed into the dog park per session for safety reasons and to prevent overcrowding.
6. Dog owners are reminded to tidy up after their dogs and are required to bring their own scoop and disposable paper bags. Please seal used bags tightly before disposing in designated waste bins. We would encourage you to “toilet train” your dog at a designated pet toilets.
7. Toddlers and children (below 13 years old) must be accompanied by adult at all times in the dog park.
8. Smoking, alcohol and drugs are prohibited in the dog park.
9. No cycling, jogging, rollerblades, skateboarding and strollers in the dog park.
10. To enter at your own risk and by entering, agree to abide by rules and regulations of the dog park and be responsible for their own dog(s) behavior.
11. Designated area, hours and days for dog obedience training classes will be determined by the Operator with the Management’s consent, and subject to change without notice.
12. The Management reserves the right to prohibit any person or dog(s) entry to the park that may cause a nuisance or pose a threat to the safety of the public and dogs in the dog park.
13. The Management reserves the right to make necessary changes on the rules and regulations, close the park for events etc., without prior notice.
14. Bandar Eco Setia Sdn Bhd, its employees, servants and agents shall not be liable for any mishap, injury, death, embarrassment, damages or loss of personal property of the member(s) and/or its accompanying guardians, family and friends whilst on and within park.
